# REQUEST FOR INFORMATION

Toolserv Norway is a global supplier of downhole equipment for drilling and completion operations, offering both sales and rental solutions to major operators worldwide.

We are seeking information from established local service providers in Georgetown, Guyana, who can support Toolserv's operations with ExxonMobil and possibly other clients in the region. The selected partner will play a critical role in ensuring reliable importation, storage, servicing, and delivery of downhole tools to offshore projects.

This RFI aims to identify capable vendors with the facilities, workforce, and expertise required to manage Toolserv's equipment locally in a professional, timely, and cost-effective manner.

As part of Toolserv's global strategy, we place strong emphasis on creating long-term value and contributing to the development of local communities where we operate. This includes supporting local employment, training, and knowledge transfer to ensure sustainable benefits beyond our core operations. While we recognize that not all service capabilities may be available in-house, we expect our local partner to have the ability to coordinate and organize any missing services through trusted and reliable third-party providers. This ensures that Toolserv and our clients receive seamless, high-quality support while enabling broader participation of local businesses in the supply chain.

#### 1. Project Overview

Toolserv anticipates regular activity in Guyana, requiring local support to:

- Import and clear downhole equipment (both rental and sales).
- Provide secure storage facilities for tools between jobs.
- Handle logistics for delivery and return of equipment to/from quay side or 3 party locations.
- Manage returned equipment including cleaning, inspection, and preparation for the next deployment.

- Conduct mechanical servicing, pressure testing, and make/break services.
- Provide sales and technical representatives who can frequently visit ExxonMobil
  offices to ensure proper equipment application and timely delivery.

The partnership should enable Toolserv to maintain close client relationships while ensuring high standards of safety, quality, and service delivery in Guyana.

### 2. Scope of Services

Respondents should indicate their ability to provide the following services:

- Logistics & Importation: Customs clearance, inbound/outbound freight handling.
- **Storage & Handling**: Secure warehouse facilities for short- and medium-term storage.
- **Inspection & Maintenance**: Cleaning, visual and functional inspections, mechanical servicing, and preparation for offshore dispatch.
- **Testing Capabilities**: Pressure testing and make/break services.
- **Local Freight**: Transportation between port, warehouse, and client or 3<sup>rd</sup> party locations.
- **Sales & Client Support**: Availability of sales representatives to maintain frequent contact with ExxonMobil offices in Georgetown.
